

Thank you for submitting the enclosed documents in support of your application for British citizenship. All the information has been noted and we will not need to see them again.



## 5. 签证申请类别介绍

入籍是重要的步骤，入籍分配给获得公民资格的人英国公民同样享有的权利。实际上所有种类移民获得移民豁免资格至少要 12 个月的时间，就是各类移民申请者的永久居留权 (Indefinite Leave to Remain) 或者欧洲经济区国家公民和他们家庭成员的永久居留权。

I am returning the enclosed passport and other documents which your client provided in support of their application. Your client's Biometric Residence Permit (BRP) will be sent to you under separate cover. You should receive your client's permit within 7 working days. However, if you do not receive the permit within 10 working days of the date of this letter, please use the service at [www.gov.uk/brp](http://www.gov.uk/brp). **Please note that on delivery the courier will require proof of identity and a signature to confirm receipt of the package.**

**Your client is advised not to make any travel arrangements until he has received his Biometric Residence Permit.**

The Biometric Residence Permit is a residence permit which holds your client's biographic and biometric information and shows his immigration status and entitlements while they remain in the United Kingdom. The permit replaces the vignette (or sticker) and ink stamps previously placed in the passports of those granted permission to remain in the United Kingdom. A leaflet will accompany the permit which will give your client more information about it.

If your BRP is lost, stolen or damaged you must tell the Home Office or risk a financial penalty. Details about reporting lost, stolen or damaged BRPs are on our website at: <https://www.gov.uk/biometric-residence-permits/lost-stolen-damaged>.

For some case types a leaflet may be enclosed giving details of the conditions of stay. **BRP Unique Number:**

You may already have received a letter from the Home Office advising you that a decision on your application has been made and any supporting documents returned to you. Please find attached your Biometric Residence Permit (BRP). You must comply with time limit and any other restrictions placed on your stay in the UK: these are set out on the BRP or in your decision letter.

Your BRP is an important document and you should look after it carefully. It is proof of your right to stay, work or study in the United Kingdom and may be used as a form of identification (for example, when setting up a bank account). You can also use the online right to work checking service to demonstrate your right to work to an employer; simply go to [gov.uk/prove-right-to-work](http://gov.uk/prove-right-to-work)

The BRP has a unique number in the top right-hand corner, which is also shown at the top of this letter. You should keep this letter safe and in a separate place to your BRP as you will need the unique number to apply for a replacement if your BRP is lost, stolen or damaged. You should also take a photocopy of the front and back of the BRP for your own records and remove from the back of the BRP any residual glue used to affix it to this letter. You must not laminate your BRP as this will damage the card and you will be responsible for paying for a replacement if you do so.

Please check your BRP to make sure that all the details on it are correct, as you are required by law to have a BRP that accurately records your personal details and the type of permission you have to be in the United Kingdom.

If you think that the length of stay or conditions of stay are wrong **and** your application was made from within the United Kingdom please go to [gov.uk/ask-for-a-visa-administrative-review/if-you-are-in-the-uk](http://gov.uk/ask-for-a-visa-administrative-review/if-you-are-in-the-uk)

For all other mistakes please use the service at [gov.uk/brp](http://gov.uk/brp) within 10 working days of receiving your BRP. If you cannot use the online service please send your details including the BRP unique number, your full name, date of birth and contact details along with an explanation of what you think is wrong with the BRP to the Bristol address at the top of this letter, **but you will wait longer for a response.**

We are introducing an aligned BRP and National Insurance Number (NINo) process, on a phased basis, for migrants aged 16 or over. This currently applies to migrants who have been granted leave in any Tier 2 category or as a refugee. In such cases, your NINo will appear in the remarks on the reverse of your BRP, so there is no need for you or your employer to make a separate application to the Department for Work and Pensions to obtain one. ## 5. 签证申请类别介绍

“企业家移民签证”（Tier 1 Entrepreneur）即业界俗称的“英国 20 万英镑企业家移民签证”。这项签证可视为相对保险且容易实现的移民方案，以申请成功率高、审核时间较快，而备受海外高净值移民欢迎。该项签证由内政部以“3 年+2 年”的形式发放，即先授予申请人 3 年时间启动投资项目，然后可再申请 2 年的续签；如此 5 年后，企业家移民签证持有者若通过内政部审核，即可获得英国永居。该项签证的持有者可携全家一起前往英国（子女的年龄需低于 18 周岁）。每年离开英国不超过 180 天并且满足投资要求，最终全家都可获得英国永久居留权。
